➤ **Rate / proposal parameter:**

1. Cost of milling, handling, transportation and stacking at delivery point charges (Rs. /Qtl, including GST) of raw pulses stock to be issued to the miller at Fixed conversion ratio of 91.50% for the milling and supply of Chana Whole.
2. Cost of residuals payable to Kendriya Bhandar/ CGSCSCL @ Rs. 1000 per quintal for quantity equivalent to 8.50% of raw material.
3. Recovery of cost of gunny bags from the successful millers will be done @ Rs. 50/Quintal the amount will be deducted by CGSCSCL from the milling charges payable.
4. Cost of arranging for transportation of Milled Pulses to CGSCSCL delivery centers at taluka level in the state of Chhattisgarh.
5. All levies, duties & takes including GST, works contract tax, total taxes, income tax and other taxes, if any.

➤ **Terms and Conditions:**

- a) **Eligibility for submission of rate/proposal.**
1. Miller must be empaneled with Kendriya Bhandar under pulses milling.
 2. The miller should have owned milling facility in the state of Chhattisgarh also should submit valid Factory license copy.
 3. The miller should submit valid FSSAI license for manufacturing, storing and packaging of pulses.
 4. The milling capacity of the miller will be considered as per the document submitted and also verify by physical verification.
 5. Miller should submit valid Chhattisgarh GST certificate copy.
 6. Miller should submit valid Chhattisgarh Mandi License copy/ same will be provided within 15 days of signing of contract.
 7. Miller should submit valid prof of EMD submission.
- b) **Other Terms and Conditions:**
1. The miller should pre-inspect the mapped stock of raw pulses its own cost, before submission of proposal.
 2. Kendriya Bhandar shall be at liberty to cancel / postpone the called tender.
 3. Kendriya Bhandar shall be at liberty to accept or reject any rate/proposal without any reason provided to anybody.
 4. In case of any dispute/ambiguity related to this tender, Kendriya Bhandar management decision shall be final and binding on miller in any of the dispute/ambiguity and further such dispute will be adjudicated and resolved in a Court of law in Delhi.
- c) **Terms and Condition for submission of Rate/Proposal:**
1. The miller shall submit the rate in sealed envelope and physical submitted at our Raipur Branch office before 28.04.2024 (Up to Time 05.00 PM).
 2. Only eligible miller shall get the mail by Kendriya Bhandar on their registered email ID after evaluation of eligibility documents submitted by miller for the rate/proposal submission at our Raipur branch office.
 3. Only those millers rate/proposal will be accepted and consider by the management, who will get the mail from Kendriya Bhandar for submission of rate/proposal.
- d) **Penalty terms:**
1. Late delivery penalty @ 1.00% plus GST will levied on miller or the penalty amount as imposed by CGSCSCL.
 2. Any other penalty or default clause imposed by CGSCSCL, miller will be only sole responsible for all risk and implications.
- e) **All other terms and condition will be applicable to the miller as per the agreement by the CGSCSCL.**

Specifications For Chana Whole

(Specifications of Chana Whole is based on food Safety & Standard Authority of India Regulations 2011)

Chana whole shall be the dried grains of gram (*Cicerarietinum* Linn.) It shall be sound, clean, sweet, wholesome and free from unwholesome substances. It shall also conform to the following standars, namely:-

Moisture	Not more than 16 per cent. by wight (obtained by heating the pulverised grains at 130°C-133°C for two hours)
Foreign Matter (Extraneous matter)	Not more than 1 per cent.by weight of which not more than 0.25 per cent.by weight shall be mineral matter and not more than 0.10 per cent. by weight shall be impurities of animal origin.
Other edible grains	Not more than 4 per cent by weight.
Damaged Grains	Not more than 5 per cent by weight.
Weevilled grains	Not more than 10 per cent by count.
Uric acid	Not more than 100mg. per kg
Aflatoxin	Not more than 30 micrograms per kilogram

Provided that the total of Foreign matter, other edible grains and damaged grains shall not exceed 9 per cent by weight.
