**NOTIFICATION**

Reference is invited to the Notification of even number dated 01<sup>st</sup> August , 2<sup>nd</sup> August, 4<sup>th</sup> August and 18<sup>th</sup> August 2017 relating to the elections to Kendriya Bhandar.

2. Vide Notification dated 18.8.2017, the election process was temporarily kept in abeyance till 22.8.2017. The Writ Petition (C) No.7073/2017 filed by Shri Yogendra Saraswat Vs Union of India in the Hon'ble Delhi High Court came up for hearing on 22.8.2017 and was disposed of by the Hon'ble High Court and the formal orders of the Court are awaited. However, during the hearing the Hon'ble Court , inter-alia, directed the Returning Officer to continue the election process for Kendriya Bhandar.


3. The election process relating to scrutiny of nominations, announcement of valid nominations, withdrawal of nominations and intimation of final list of contestants to Kendriya Bhandar have been rescheduled as follows:-

4	Intimation of names of contestants by Returning Officer to the Kendriya Bhandar	29.8.2017	Upto 6 p.m.

4. On 25.8.2017, between 1 p.m. to 4.00 pm, the contesting candidates of the respective constituency will be allowed to examine the nomination papers available with the Returning Officer, with a view to satisfy themselves that the nomination papers submitted by the contesting candidate (s) is/are valid.

5. There is no other change in the process of elections from 4.9.2017 till 24.10.2017, as intimated vide notification dated 4.8.2017.
