OFFICE MEMORANDUM

Subject: Elections in Kendriya Bhandar-reg.

The undersigned is directed to refer to Kendriya Bhandar's email dated 20.11.2025 on the subject mentioned above and to state that the matter has been examined in light of this Department OM No.11013/1/2016-Estt.A-III dated 27.02.2020 read with OM dated 05.08.2019 which clearly stipulate that a Government servant may be allowed to hold elective office in any body, whether incorporated or not, for period of two terms or for a period of 5 years, whichever is earlier, for which prior sanction would be required when a Government servant contests an election in such body, as per existing rules.

- 2. Since, Kendriya Bhandar is a multi-state cooperative Society having members exclusive from Govt. service (different from other Societies) and the aforesaid DoPT's guidelines regarding obtaining prior permission before contesting any election is applicable to all Govt. Servant, therefore, the aforesaid DOPT's OMs are well applicable in the KB election and these guidelines should be strictly followed and only those Government Servant having prior permission from their controlling Department may be allowed to participate in the election.
